- NOTES:**
1. ALL Turn Around checks to St. Jude Children's Research Hospital will be given directly to the Circle of Life office for processing.
 If you would like it returned to you, please indicate that to us in writing.
 If you use Circle of Life or ALSAC / St. Jude materials / supplies for your event, you may NOT use the Turn Around Fund.
 2. A Turn Around Check cannot be issued directly to an individual or reissued to a Chapter or State Council.
 The Internal Revenue Service does not allow the Foundation to use Turn Around Funds for donations to the following:
 ESA Disaster Fund, State/Regional Love or Care Funds.
 3. All checks will be mailed to the donor / chapter / for distribution to the charity, unless indicated otherwise.
 4. Checks that must be re-issued for whatever reason will have a service fee of \$ 25 deducted from the check.
 5. **Checks not cashed within 120 days of the date of issue will be considered a donation to the ESA Foundation General Fund.**
